

Transformation action

Waco Africa achieved a level 2 B-BBEE rating effective until 12 December 2025. The Waco Africa Cadet Scheme provides high-potential individuals from previously disadvantaged backgrounds with core business skills. The scheme is offered to existing employees who do not have a matric certificate or a National Qualifications Framework (NQF) level 4 qualification. Cadettes are enrolled on a learnership involving practical work and after-hours study towards an NQF level 4 in general management, followed by on-the-job mentorship and exposure to different elements of the business. This is available to internal or external graduate NQF level 4 candidates who receive on-the-job mentorship. Waco is also sponsoring university students in civil engineering, mechanics and logistics.

About 37% of our middle senior management are black of which most have come through from our training interventions.

Environmental action

Over the past few years, Sanitech has developed several resource-efficient solutions for the increasingly water-stressed Southern African region. The steam clean toilet uses steam and a rotating bowl to save water and bypass the need for water infrastructure. The new informal concept (NIC) toilet reduces water usage by up to 100 times less than a conventional domestic toilet. To reduce the costs associated with waste removal, Sanitech developed portable and scalable wastewater and water treatment plants to enable it to treat waste on site.



WWTP

Our robust, mobile treatment plants easily convert domestic wastewater into reusable, environment friendly water. Plus, we purify reclaimed water to meet drinking water standards, providing revolutionary water conservation method.

Our choice of standard modular equipment, driven by Jar Tests and Chemical Analysis, along with a comprehensive chemical programme ensures efficient wastewater treatment in compliance with local by-laws.

Khusela Toilets – An elliptical shaped top structure with above ground waste tank

The Khusela Unit is an innovation that replaces the traditional open pit latrines and is a ground-breaking alternative to conventional open pit latrines. The unit is designed to ensure zero environmental and underground contamination. The unit requires no pit for installation and it features a secure, sealed service

hatch to prevent any waste exposure to users. Where possible, we involve the local community for the installations, thereby making them apart of the transformation towards better sanitation services.

Sani Sure

Sani Sure is a state-of-the-art device that enables seamless tracking and monitoring of septic tank levels on customer sites. With this innovative solution, we can effectively monitor our customers' tank levels with real time data and notification, allowing us to plan accordingly. By doing so, we alleviate the stress and hassle associated with worrying about tank levels and the potential for overflow.



The Sani Sure Unit is compact andwaterproof, ensuring durability and reliability. It boasts an impressive battery life of up to four years.



Electric vehicles - Sanitech is the first company in the integrated hygiene space in SA and the WACO Group to launch Electric vehicles.

Operating costs are lower than traditional gasoline-powered cars, as they require less maintenance and use cheaper fuel. Electric vehicle production requires less energy, water, materials, chemicals

and waste products compared to conventional car manufacturing processes. Time compared with petrol or diesel-powered cars.
